Riding the SFIA Roller-Coaster

At the annual MFA meeting on May 16, 2014, I characterized MFA's involvement with the Sustainable Forest Incentive Act (SFIA) – liking it to riding a roller-coaster over the past three years. A recap of what's happened over that period follows.

Beginning with the 2011 legislative session, MFA crafted and had introduced a bill (HF 1121) to reform the SFIA. It was not heard in committee though, because the next day, the Tax Committee Chairs in both Houses introduced their own proposal to repeal the SFIA, which the Legislature did as part of the Omnibus Tax Bill. But, the Governor vetoed the bill. It was during the subsequent special legislative session, that the repeal was "repealed," resurrecting the SFIA.

The commotion over the SFIA may have contributed to the Office of the Legislative Auditor (OLA) beginning an evaluation of the SFIA. On November 19, 2013, the Auditor presented his report to Minnesota's Legislative Audit Subcommittee. The Auditor questioned the level of SFIA payments citing one instance where the annual incentive payment was more than 300% of one enrolled landowner's property taxes. The Auditor made a number of recommendations to address other issues that his office identified as problems. And, the report went further in recommending that if the problems weren't addressed, he recommended repeal of the SFIA.

For our Annual Meeting, MFA secretary Lyle Keller compiled and presented a summary of MFA's significant actions during the past year. Here is his list:

- 1. Establish a Forester Phone Line by retaining retired DNR forester Dean Makey to answer members' questions at no cost to members.
- 2. Publication and Distribution of Jerry Lenz' History of the Minnesota Forestry Association 1876-1930's and 1978-1988.
- 3. Successful handling of the silent auction by MFA at the National Tree Farm convention held in Minneapolis in July, 2013. The auction was described as "best ever" by the Tree Farm staff. MFA's efforts were led by Board members Dennis Thompson and Bruce ZumBahlen.

- 4. Launch of the Call Before You Cut program on a statewide basis as a free service for all Minnesota's private woodland owners. MFA's CBYC program is referenced on the national CBYC website.
- 5. Adoption of a new Perpetual Membership Category to accommodate to accommodate memberships for any estate, corporation, limited liability company, limited liability partnership or similarly structured entity.
- 6. Securing the financial status of MFA as the best it has been any time in recent history.
- 7. Creation and sale of MFA branded "No Trespassing" signs.
- 8. Active participation in the U of M's Woodland Owner Conferences in Bemidji and Rochester.
- 9. Establishment of a member contact program which is being carried out by administrative assistant Carol Cartie. Carol makes phone contact with members to explore their opinions of MFA and what services they desire. Progress is understandably slow due to the time spent with each member.

Member Profile: Steve & Christy Earley and Their Cedar Grove Farm, International Falls, MN

Late summer in the early 1930s, Margaret Earley, Steve Earley's aunt, had a dilemma. For her 4-H calf to show at the Minnesota State Fair, rules required a farm name. Inspiration was an upland cedar stand just north of the farm house, and Cedar Grove Farm was her choice. Margaret is gone but the cedar stand, now over 130 years old, still stands. When Steve's family started selling garden produce and custom Christmas wreaths, the business name was a "no-brainer." After 80 years, Margaret's Cedar Grove Farm name was revived and the fourth generation of the Earley family to earn a wage at Cedar Grove Farm began.

Steve and Christy are both retired – Steve from the Boise paper mill in International Falls, and Christy from Minnesota Extension Service. They have two teenagers, Eric and Anna, who get an equal share of revenue from Cedar Grove Farm as long as they do equal work.

Christy and the kids make and sell 60 to 70 Christmas wreaths each year. The effort covers two months. Harvesting of balsam fir, spruce, pine, cedar and red-osier dogwood begins after the second hard frost and, if lucky, ends before deer season. A double frost assures the greens remain green for a long time. All the greens are locally harvested from the Farm or a friendly neighbor's woodlot. Wreath making is Christy's specialty, handed down from her mother, a national award winning wreath maker.

Beginning in early July, the family sells produce from the garden such as spinach, sugar snap peas, rhubarb, celery and pumpkins. The gardening is tough work and not as popular with the equal partners during the hot summer. Work begins in April with the starting of seeds inside, even though snow piles remain outside. Garden planting is done by Memorial Day. Several days each week are devoted to weeding, fertilizing and, in dry years, watering the garden.

Cedar Grove Farm covers 100 acres south of the Canadian border. The farm is mostly clay soils with 30 acres of aspen, balsam fir and white spruce and 70 acres of fields. While the first and second generation of Earleys toiled clearing the land of trees so crops could be planted and dairy cows pastured, the subsequent generations have been planting trees in those same fields and pastures.

The woodland has been enrolled in the Tree Farm Program since the 1980s. Steve is active in Tree Farm's Grass Tops program which advocates for better policies and laws that benefit private woodland owners, in Minnesota and across the country.

Steve was recruited for MFA membership in the early 1980's by Mike Latimer. To include Christy and the children, they now have a Family Membership. Recently, Steve served on MFA's Board of Directors in 2012-2013.

Will there be a fifth generation to live and work on Cedar Grove Farm? Only time will tell but one teen already is looking at a career in forestry.

The Auditor's evaluation was a fair assessment of the program. Frankly, the issues he raised were not a surprise to MFA's Government Relations Committee. In fact, many of the issues that he identified were some of the very same ones MFA had attempted to address with HF 1121 in the 2011 legislative session.

Late December 2013, Senator Saxhaug and Representative Dill requested the MN Dept. of Revenue (DOR), the MN Dept. of Natural Resources (DNR) and the MN Forest Resources Council (MFRC) convene a SFIA stakeholders group to study the OLA's recommendations and come forth with proposals to improve the SFIA. Under the MFRC's leadership, that stakeholder group has been formed and has had its initial meeting. MFA is represented on that group along with representatives from the following interests: conservation, outdoor sports, recreational, county assessors, large forest ownerships and forest industry as well as staff from the DOR and the DNR.

Fast forward to this Spring. A surprise! Representative Hansen

introduced HF 2782 to repeal the SFIA. With only a two-day notice before it was heard in the House Property and Local Tax Division, MFA testified against its repeal along with others. The bill was laid over for consideration in the House Omnibus Tax Bill.

What emerged in the Tax Bill (HF 3167) was only a repeal of several definitions used in the previous methods for calculating the annual SFIA payments that are now obsolete since the annual payment is now set in statute at \$7.00 per acre. Interestingly, those definitions are the same ones that MFA has recommended to repeal. Ultimately, the Omnibus Tax Bill was passed without repealing even those definitions. Senator Skoe, Senate Tax Chair, stated that he would like the stakeholder group to work over the summer and fall and propose amendments to the SFIA for the next legislative session rather than take them up this session.

Stay tuned. Future issues of this newsletter will report on the stakeholder group's progress.
